Service to Others

There's no higher purpose than service to others. — 'Socrates' in "Peaceful Warrior"

What does service mean to me? Within the group, service is making coffee, helping to set up or clean up, chairing, taking part in the business meetings, taking a service position such as GSR, secretary, treasurer, etc. It can also be service within the District: attending district meetings, servicing as DCM, secretary, treasurer, committee chair, representing my homegroup as GSR, helping with district functions such as the Winter Workshop and Cluster Forums, or even helping with area functions such as the Pre-Paid Convention. It can also be as simple as working with another alcoholic: as sponsor, sponsee, going on a 12-step call, sharing at meetings, talking with a newcomer, or just simply being there. One thing I've learned about service, besides putting principles over personalities: it's not about exerting your voice, but those of the members, groups, districts you're representing. You're merely a communication vessel, a facilitator, but you are also serving an important role.

AA Service Structure is represented by an upside down pyramid, with fellowship on top. There are service positions at the group, district, and state levels (GSR, DCM, any of the committees—Corrections, Treatment and Accessibility, Public Information/Cooperation with the Professional Community, Grapevine, Archives, Communication) that all serve to keep each level of Alcoholics Anonymous connected in our primary purpose of carrying the message to the still sick and suffering alcoholic. Important Dates in A.A. History

(Details from <u>http://www.a-lassociates.com/aa/HISTORY_PAGE/dates.htm</u> and was collected & assembled by Nancy O. of Virginia. This is a Maryland AA History site.)

Oct 1936 - Bill C, a Canadian alkie staying at Bill's house, commits suicide using a gas stove.

Oct 20, 1928 - Bill wrote promise to Lois in family Bible to quit drinking. By Thanksgiving added second promise.

Nov 9, 1966 - President Johnson appoints Marty M to the 1st National Advisory Committee on Alcoholism.

Nov 11, 1934 - Armistice Day; Bill started drinking after dry spell, beginning of Bill's last drunk.

Nov 13, 1939 - Bill wants to go to work at Towns Hospital, NY drunks want him to stay on as head of the movement.

Nov 28, 1943 - Bill guest speaker San Quentin Penitentiary. (sometimes dated Dec 2, 1943)

Dec 1955 - 'Man on the Bed' painting by Robert M. first appeared in Grapevine. Painting originally called 'Came to Believe'

Dec 6, 1939 - Bert the Tailor lends Works Publishing \$1000.

Dec 11, 1934 - Bill admitted to Towns Hosp 4th/last time (fall '33, '34 in summer, midsummer and final admittance).

Dec 12, 1934 - Bill has Spiritual Experience at Towns Hospital.

Dec 13 or 14, 1934 - Ebby visited Bill at hospital, brought William James's book, "Varieties of Religious Experience".

The positions also help with the flow of communication between the groups, districts, areas (state), and GSO. Your voice matters, as does your group's, district's, and area's. The group members vote at their group business meetings; the GSRs only facilitate and carry the Group Conscience to the District and Area levels where they vote. The DCMs facilitate at the District and Area levels; they only vote at the DCM meeting with the Delegate and the Office Committee. The delegate does not vote at the Area Level, but represents our collective group conscience at the GSO level. The Delegate, DCM, GSRs all function to provide information back to the Group level.

I've been told and have heard around the rooms that if someone asks you to do something within AA (in terms of service work), you don't say no. You suit up and show up. This is how I first got involved with service at the group level. My home group decided that I would make a good GSR and voted me in...then told me about it. I tried to use the excuse that I had no idea what that entailed. They simply told me not to worry about it, they would be there to help me along the way....and they were. I went to the district meetings and to the Georgia State Service Assemblies and learned a lot— about the traditions, the functioning of AA as a whole, the various committees whose focus is carrying the message. I also learned how to put principles over personalities and this has helped me beyond measure both in AA and in all other areas of my life.

I learned to trust the process and have allowed others within AA to lead me to my next service position. And this is where Jim T. enters the picture. He approached me at a meeting saying that he needed some women to take a meeting to the new women's prison up in Hartwell. I was reluctant since I'd never been to jail or prison and had no clue. He reminded me that they knew plenty about being in prison; what they did not know about was how to get sober and stay sober. That was nearly 7 years ago! I actually felt comfortable there; the ladies all had so very many varying backgrounds and life ordeals that they had to endure, many of which contributed to them drinking/ using and getting imprisoned. It's been increasingly rewarding. Only in this past year have I not been as actively volunteering there due to my work schedule. I still go when I am able.

"Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics." — BB p. 89.

Biography: "The Unbeliever"

Henry (Hank) P., New Jersey.(OM and 1st edition, p. 194.)

Hank was the first man Bill W. was successful in sobering up after returning from his famous trip to Akron where he met Dr. Bob. Thus, Hank was A.A. #2 in New York prior to resuming drinking about four years later. His original date of sobriety was either October or November 1935.

Hank was a salesman, an agnostic, and a former Standard Oil of New Jersey executive, who had lost his job because of drinking. He wound up at Towns Hospital, where Bill found him in the fall of 1935. The first mention of Hank in the Big Book is on page xxix of The Doctor's Opinion. He is believed to be the man Dr. Silkworth described who seemed to be a case of pathological mental deterioration. When Bill and Lois lost their home on Clinton Street, Brooklyn, it was to Hank P.'s home in New Jersey that they moved for a short time.

He and Jim B. ("The Vicious Cycle"), lead the fight against too much talk of God in the 12 steps, which resulted in the compromise "God as we understood Him."

Ruth Hock said the Big Book would not have been written without Bill, and it would not have been published without Hank. And Hank wrote, except for the opening paragraph, the chapter "To Employers."

But Hank became very hostile toward Bill. Problems developed between them over the way Hank was setting up Works Publishing Co., as a for profit corporation, with himself as President. As a result of the feedback from group members, Bill listed himself as the sole author of the Big Book as a means of counter-balancing this.

There were other problems over money, and over Ruth Hock. Hank wanted to divorce his wife, Kathleen, and marry Ruth, and when Ruth decided to go with Bill when he moved the A.A. office out of Honor Dealers, Hank was furious. Bill paid him \$200 for the office furniture (which he claimed he still owned, but which had been purchased from him earlier), in exchange for Hank turning over his stock in Works Publishing, as all the others had done. Hank then went to Cleveland to try to start problems for Bill there.

No one knows exactly when Hank had started drinking again, but in the diary Lois W. kept there are various September 1939 entries that mention that Hank was drunk. He did get back on the program for a short time at some later date but it didn't last. Nevertheless, A.A. owes Hank a debt of gratitude for his many contributions during his all too short period of sobriety.

He died after a long illness at Glenwood Sanitarium in Trenton, New Jersey, on January 18, 1954, at the age of fifty-seven. Lois W. ascribed his death to drinking. Funeral services were held Thursday, January 22 at Blackwell Memorial Home. Rev. A. Kenneth Magner of the First Presbyterian Church performed the service.

Sober Daze is using the Grapevine 20 questions for old-timers format to gain insights from our District 12A and 12B members with over 10,000 days sober. Our Long-Timer in this Issue is Don B of the Martinez Group.

- What was AA like when you came in? How is it different? The Old-Timers were not nice. "Oh, its O.K. just to keep coming back."
- What was 12th Step work like when you were new? *We were told and not asked to get involved.*
- How did your group treat newcomers? Constant slippers? 13th steppers? Members in meetings with multiple addictions? *Welcomed Newcomers. Told Slippers they were going to die. Told them to only discuss alcohol.*
- What special occasions do you recall doing AA service? Faith without works is dead. I have to trust that God's will is all-powerful.
- What do you recall of early conferences, assemblies and conventions? *The early days of Winter Workshop.*
- What contributions would you say you've made to the Fellowship? *Stayed sober. Showed that the Principals work.*
- What do you think of AA today? Not enough time spent on the primary purpose.
- After many years, do you still have a sponsor? Do you still sponsor people? What are your thoughts about sponsorship? *Yes. I think Sponsorship is not for everyone.*
- Are there ever moments when you lose your faith or your connection to your Higher Power? What do you do when this happens? *No. Balance is everything.*
- If there is one thing you could go back and do differently, what would it be? Nothing.
- Is there something *you* learned from old-timers that you hold dear? *When you share, say what you need to and sit down.*
- How long did it take to finish your 9th Step? What was your most memorable amend? 2 1/2 years.
- What would you tell a new member today? *Get a Home Group, Sponsor, and share honestly.*

Twelve Tips for a Sober, Joyous Holiday Season

- 1. Line up extra AA activities--meetings, speaking, phone answering.
- 2. Entertain AA friends, especially newcomers.

- 4. Find out about special holiday parties, meetings, or other events at groups in your area, and go. If you're shy, take a newer member.
- 5. Skip drinking occasions you're nervous about. Remember your drinking talent for making excuses? Put it to work for you in sobriety.
- 6. If you must attend a drinking party, and can't find a fellow AA to come with you, keep some candy handy.
- 7. You don't have to stay late. Plan for an "important date."
- 8. Go to church. Any church.
- 9. Don't sit around brooding. Catch up on reading, letters, walks.
- 10. Remember, one day at a time. Don't start now to worry about all those "holiday temptations."
- 11. If you can't give material gifts this year, you can give love.
- 12. "Having had a . . ." You already know the Twelfth Step!
