#### RULES & REGULATIONS - A.A. FLOOR - TOWNS' HOSPITAL

NOTE: Copied word for word from original document including double spacing after periods As the Intergroup is asked so often the mechanics of sponsoring and caring for a patient at Towns', we submit for your information the following Rules & Regulations which must be followed literally to avoid confusion and delay.

- 1. During the hours of 10:00 A.M. to 8:00 P.M. weekdays and noon to 6:00 P.M. Sundays and Holidays; anyone wishing to hospitalize a patient on the AA floor must first contact the Intergroup Office to determine whether there is a vacancy. During other hours, when Intergroup is closed, AA members may contact Towns' directly to make arrangements for admission. The following morning, the Hospital will confirm the patient's eligibility with the Intergroup Office. If the patient is ineligible, he shall be removed from the AA floor.
- 2. No ambulance cases are accepted or patients with medical complications other than alcoholism.
- 3. Bill of \$100.00 plus \$5.00 for incidentals must be paid to the hospital upon admission in cash no checks no refunds.
- 4. Sponsors must sign registration book upon admission of patients and on taking patients out.
- 5. Members of AA shall be permitted to visit on the AA floor during the hours of 2 PM to 5PM and from 6 PM to 10 PM. Sponsors may visit at any reasonable hour.
- 6. Women patients must be sponsored and taken to the hospital by women AA's. Men patients must be sponsored and taken to the hospital by men AA's and visited only by men AA's. NO OUTSIDE VISITORS are permitted on the AA floor.
- 7. Women and men patients are NOT to fraternize in the halls, in Duffy's Tavern or in any of the rooms.
- 8. If a sponsor cannot be up at Towns the day his patient is discharged, please notify the Intergroup Office in sufficient time to enable us to get a substitute sponsor. When calling Intergroup office, please ask for the Secretary in charge of hospitalizations.
- 9. A patient can be hospitalized ONLY ONCE in the AA ward at Towns. NO REPEATERS ON THIS FLOOR.
- 10. TO NURSES AND SPONSORS Please call Intergroup regarding anything SPECIAL OR UNUSUAL about a case so we may help get the matter straightened out and have a record of same.

These Rules and Regulations have been carefully worked out for the benefit of the greatest number of AA members and/or prospective AA members. The cooperation of all will be gratefully appreciated. *Please see George to view original document.* 

#### WHO'S WHO IN THE $12^{TH}$

Jeff S., a member of the Martinez Group and the D.C.M. for district 12A, is a tremendous power of example for the importance of following the "directions" as written in the book Alcoholics Anonymous.

Jeff was born in Germany and raised in Augusta. He has had numerous attempts at staying sober since he was first court ordered to AA at age 19. At that point he thought the people in A.A. were "a bunch of damn religious fanatics". Little did he know where his resistance and recovery were taking him. Jeff continued with his addiction until age 23 when he attended the first A.A. meeting with a desire to stop drinking. At this time his dad, who had been his drinking buddy decided to get sober in order to support Jeff in his recovery. He wanted to support his son and to always be able to provide him with a safe, alcohol-free place to be.

Jeff had a close relationship with his parents. His mother died 14 years ago when he was 2yrs sober resulting in relapse. His dad remained sober and continued to have a loving relationship with Jeff until his death 8 years ago. Jeff relapsed 1 year later. During this relapse Jeff was playing golf with friends hitting the 13<sup>th</sup> hole pretty hard then they headed out to the truck to leave. The driver and front seat passenger neglected to wear seat belts. Jeff was in the back seat with Keith who always wore a seat belt. Jeff noticed this and put his on. This was Divine Intervention for both he and Keith. There was a wreck and both Jeff and Keith survived. Jeff stayed out for 2 more years of painful addiction.

During Jeff's recovery periods he made numerous attempts to put a 4<sup>th</sup> step together with and without a sponsor. He never got past resentments. On May 25, 2021, Jeff's sobriety date, he began working with a sponsor and was able to follow directions completing his step work, "by the book" at 68 days sober. What resulted was powerful, he finally understood that there are directions and if he followed them his life would change in ways he never imagined. He describes the steps as something that is practiced and lived. It isn't enough to "work" them, it's about living them. He talked about the 10<sup>th</sup> step as something he uses on a daily basis to keep him in check. Today Jeff's life is very full with A.A., friends, sponsees, and work. He is successful in his life because he lives a program of recovery.

Jeff is active in service work...he was the GSR of the Martinez Group for 2.5 years and now D.C.M. His message to newcomers or someone coming back? "No matter what, don't ever stop coming back and work the program that is outlined in the Big Book".

Thank you, Jeff for your experience, strength and hope. Your commitment and service work to A.A. does not go unnoticed. You are an example of "how it works".

### **Doing the Impossible**

12th District Central Office is located at 113 Camilla Ave in Martinez in the Westside Club building. The Westside Club are our landlords; they do not operate the Central Office. The office sells Conference and Non-Conference literature, Chips and Medallions. It maintains a website (augustaaa.org), 24 hr. Answering Service, quarterly newsletter (Sober Daze). The Office is run by volunteers. There are no paid Employees.

Several years ago, I was in Chicago for a meeting for all of A.A. Central Offices in North America. While there I was talking to the Manager of the Los Angeles Central Office. She said she had never heard of Augusta (12<sup>th</sup> District) Central Office and could I tell her what we did there. I told her we have a book store, a website, 24 hour answering service and a quarterly newsletter. She asked how many groups support us and I told her there are about 40 groups in the Augusta area. She then said, "that is impossible". I asked her to explain and she said 40 groups are not enough to financially support what the office does.

I told her we have been doing the impossible for more than 30 years. She asked how we can do that. She asked if we charge high prices for our books. I told her prices are the lowest anywhere and that for Conference Approved literature we charge less than we buy it for. We are able to do what we do because no one is paid for working, including the Manager and the Board members. She said are you aware that if you paid even one salary, you would go broke. I told her we understood that but we have a wonderful group of volunteers who are paid not with money but with Sobriety which is priceless.

She said that is amazing and we should keep on with what we are doing.
